The inaugural ceremony was honoured by the presence of His Excellency First Vice-President of the Republic of the Sudan Mr. Ali Osman Mohammad Taha who called, in his speech, for making the PUIC a reference to recurrent questions in contemporary life, focusing on common parameters that bring Muslims together and overcome whatever that leads to dispersion.

Simultaneous with the 8th Session of the PUIC Conference, the Second Conference of Muslim Women Parliamentarians was held on 19th January 2013. At the conclusion of its deliberations, the Conference adopted a number of important recommendations, namely: adoption and approval of the Document on Muslim Woman; energizing the network of Muslim Women Parliamentarians; necessity of representing women parliamentarians in delegations that participate in PUIC meetings; and necessity of adopting positive policies that allow Muslim women to participate constructively in all fields.

The 8th Conference also witnessed the convening of the Second Meeting of the Palestine Committee on 18th January 2013. The meeting reviewed the Draft Rules of Procedure, introduced some amendments and then submitted the Draft to the Political Committee and finally to the Conference for approval.

for the first time in Indonesia, the PUIC has entered an era of qualitative conferences which will widen the scope of its role and relevance to joint Muslim parliamentary action

# Highlights on People's Majlis of Maldives

The People's Majlis is the supreme legislative authority in the country and is one of the three principal organs of the State. Unicameral in Constitution, the People's Majlis is vested with the power to enact, revise or amend the Constitution.

The Speaker and Deputy Speaker

• The Speaker and the Deputy Speaker are elected among Members of the Majlis by secret ballot.

• The Speaker of the Majlis presides over the sittings of the Majlis. He or she is responsible for orderly debates within the Majlis by ensuring that members comply with the rules and regulations.

• The Deputy Speaker takes over responsibilities of the Speaker in his absence and assists the Speaker in the discharge of functions conferred upon him.

### Structure of the People's Majlis

People's Majlis consists of 77 elected members from 21 administrative divisions of Maldives. The current 17th Majlis was instated on 28 May 2009. The term of the

People's Majlis is 5 years.

- Functions of the People's Majlis
- 1. Formulating, amending and abolishing laws.
- 2. Amending the constitution.

3. Holding the government accountable by supervision of policies and actions.

- 4. Approval of State Budget.
- 5. Holding public referendums.

6. Determination of matters related to independent commissions and independent offices.

### Sittings of the Majlis

The sittings of the Majlis are divided into three sessions a year. The speaker has the authority to assign the dates for the commencing and closing of the Majlis sessions. For a Majlis session to commence, the meeting should be presided by the speaker or the deputy speaker. The quorum of the Majlis is 26 and this number is required to begin a session of the Majlis. If the quorum is not present, the speaker has to adjourn the session. Most of the Majlis meetings are open to the public.

### Quorum

The Quorum of a sitting of the Majlis is 25 percent of its members. If any time during a sitting of the Majlis, quorum is lost, such sittings are then adjourned or suspended until quorum is met.

### **Functions of Members of Parliament**

Members of the People's Majlis should be guided in their actions by considerations of national interest and public welfare foremost, and should not exploit their official positions in any way for their own benefit or for the benefit of those with whom they have special relations. They shall represent not only their constituencies but the whole country as a whole.

### **Parliamentary Committees**

There are two types of parliamentary committees in the Majlis: Standing Committees and Select Committees.

Standing Committees are permanent committees to which members are elected by the Majlis for examining Bills in detail and to conduct further review on the subject matter for a comprehensive study.

Select Committees are temporary committees elected among members to deal with a specific issue or a Bill and they cease to exist once the inquiry is over or the issue is resolved.

There are 13 Standing Committees in the Majlis. They meet regularly to study bills, issues, petitions, motions, etc. referred to them by the Majlis. During the Second Reading, the bills are debated and amendments are proposed in the Committee. Once the review of a bill is completed, the Committee will issue a report to the main Majlis outlining their findings and recommendations pertaining to the bill.

### The People's Majlis Secretariat

The administration of the People's Majlis is served and managed by the People's Majlis Secretariat. Independent from the Government, the People's Majlis Secretariat is headed by the Secretary General. He is responsible for organizing the proceedings of the Majlis. The Speaker supervises the Majlis Secretariat.

A total of 465 candidates - 211 from 11 political parties and 254 independents - were vying for seats in the People's Majlis. The 2009 elections saw a duel between the MDP and the DRP. The latter formed an electoral alliance with the PA. Final Results:

- Maldivian Democratic Party (26 seats)
- Dhivehi Rayyithunge Party (28 seats)
- People's Alliance (7 seats)
- Jumhooree Party (one seat)
- Dhivehi Qaumee Party (2 seats)
- Independent (13 seats)

Total (77 seats)



### CV of the Speaker of People's Majlis of the Republic of Maldives Abdulla Shahid

#### Abdulla Shalli

• The Honourable Abdulla Shahid, MP was elected as the Speaker of the People's Majlis on 29 May 2009.

• He was appointed as a President's member in the Special Majlis (the Constitutional Assembly) by President Gayoom in 1994.

• He was appointed as a President's member to the People's Majlis (Parliament) in 1995 and his career in the People's Majlis continued uninterrupted since then, and in, 2000, he was elected as the Representative of the Vaavu Atoll constituency.

• The first multi-party parliamentary elections of the Maldives in May 2009, the Honourable Shahid won the seat of the Keyodhoo Constituency.

• In 1987 Mr. Shahid earned a Bachelor's Degree in Social Science (Politics) from Canberra College of Advanced Education in Australia and served in the Ministry of Foreign Affairs as an Assistant Undersecretary and after a brief period in Foreign Service, left for the Fletcher School of Law and Diplomacy at Tufts University, Boston, USA where he graduated with a Master's Degree in International Relations, in 1991.

• Prior to his role as an MP the Honourable Shahid served in the Ministry of Foreign Affairs since 1984 and rose through the ranks quickly to the post of Director in which capacity he headed the International Organizations and Conferences Department.

• He also served as the Executive Secretary to President Maumoon Abdul Gayoom in 1995.

• In 2005 he was appointed to the post of the Minister of State for Foreign Affairs, and as the Minster of Foreign Affairs on 23 August 2007.

• Mr. Shahid ended his term as the Minister of Foreign Affairs on November 11, 2008.

• Mr. Shahid enjoys soccer and plays badminton. He is fond of writing Dhivehi poetry and is married and has 2 sons and a daughter.





## Mechanisms For Combating Economic Violence Against Women 39 Member Parliments Participate in Khartoum Conference

K hartoum, capital city of the Republic of the Sudan, hosted the proceedings of the 8th Session of the PUIC Conference, on 21-22 January 2013, corresponding to 9-10 Rabi ul Awal 1434, under the slogan "Towards a United, Prudent, and Capable Islamic Ummah". The inaugural session, held in the Friendship Hall, was graced with the presence and address of H.E. Mr. Ali Osman Mohammed Taha, First Vice-President of the Republic of the Sudan, and presided by H.E. Mr. Ahmed Ibrahim Al-Tahir, President of the National Legislature and Speaker of the National Assembly of the Sudan.

The 8th Session of the PUIC Conference was attended by (39) PUIC Member Parliaments, represented by Speakers, Deputy Speakers and Heads of Delegations. There were also Observers and Guests. It was also attended by large members of Sudanese parliament members, government ministers, ambassadors accredited to Khartoum, and local and international media and news agencies personnel.

In his inaugural address, His Excellency Mr. Ali Osman Mohammed Taha Stressed that what is required is that the PUIC should be a reference to the recurrent questions in contemporary life and a rallying entity with a message, which focuses on common factors, and overcomes whatever leads to schism.

The inaugural session was also addressed by H.E. Mr. Ahmed Ibrahim Al-Tahir, and H.E. Mr. Surhaman Hidayat, Deputy Speaker of the Indonesian House of Representatives (President of the 7th PUIC Conference), as well as H.E. Prof Mahmud Erol KILIC, PUIC Secretary General.

### **Report of the Secretary General:**

His Excellency the PUIC Secretary General presented his report containing PUIC activities during the period from the date of holding the Seventh Session of the PUIC Conference, in Palembang, Republic of Indonesia, on 30 - 31 January 2012, to the Meeting of the Eighth Session held in Khartoum, Republic of the Sudan, on 21 - 22 January 2013.

The report contained participation in international and regional fora, and statements issued and those circulated by the General Secretariat upon the request of Member Parliaments as well as organizational affairs and activities. It also included important visits made to the PUIC headquarters and a review of following-up and implementing resolutions adopted by the various PUIC organs. The Report was adopted.

The Second Conference of Muslim Women Parliamentarians was held at the Friendship Hall in Khartoum, Republic of the Sudan, under the motto "Together towards Ideological Renaissance of High Values", on 19th January 2013, simultaneously with the proceedings of the 8th PUIC Conference.

The opening ceremony was honored and addressed by H.E. Mr. Ahmed Ibrahim Alall mechanisms and measures for its implementation.

Election of the Rapporteur of the Conference from the Republic of Sudan, the host State

At the Conclusion of its deliberations, the Conference recommended as follows:

1. To adopt and approve the Document on Muslim Woman, principally, and take aspects and developments at the level of implementing the recommendations.

7. Necessity of submitting detailed reports in between convening the sessions of the conference

8. Necessity of setting up a plan or agreement on the priorities and pivots which will become a focal point for evaluating the performance of States upon submission of reports.

The Meeting of the Palestine Committee:

The Second Meeting of the Palestine Committee was held on 18th January 2013 in Khartoum, and was chaired by H.E. Dr. Emrullah Isler, Representative of the Grand National Assembly of Turkey. The meeting was also attended by H.E. the PUIC Secretary General and a number of Member Parliamentarians.

The meeting reviewed the Draft Rules of Procedure Presented by the PUIC General Secretariat and introduced some amendments thereon in preparation for submission to the Political Committee and then to the PUIC Conference for approval.

# Informing About Member Parliaments: Highlights on Togo National Assembly

The unicameral National Assembly is the legislative body of Togo with 81 members elected in a political system with a term of 5 years.

### The National Assembly of the Fourth Republic:

The inauguration of the National Assembly took place March 22, 1994 with four political parties including: Rally of the Togolese People (RPT), Action Committee for Renewal Convention Forces. It has also one (01) independent member.

In fact, following the death of the President of the Republic His Excellency Gnassingbe Eyadema General, on 5 February 2005 and noting the absence from the national territory of Mr. Ouattara Fambare Natchaba (Speaker of the National Assembly), the National Assembly dismissed on 6 February 2005 the Speaker of the National Assembly by a motion of censure and the election of a new Speaker in the person of El Hadj Abass Bonfoh February 2005. Thus, based on Article 65 of the Constitution of Togo His Excellency Mr. Abass Bonfoh becomes acting President of the Togolese Republic and has 60 days to organize presidential elections.

In accordance with 22 commitments signed in Brussels on 14 April 2004 by the Government of Togo, new elections were scheduled in the first half of 2005.

With the conclusion of the Global Political Agreement (GPA) signed on 20 August 2006, the President Faure Gnassingbe Essozimna dissolved the current National Assembly on August 30, 2007 and declared the organization of anticipated elections for 14 October 2007.

After the election of October 14, 2007, three (03) political formations sit in the National Assembly as follows:

Rally of the Togolese People (RPT) with 50 deputies elected The Union of Forces for Change (UFC) with 27 deputies and finally

### PUIC Parliament Speakers Update:

Algeria: The President of the National People's Congress (NPC), Mr. Larbi Ould Khelifa received at the headquarters of the Parliament, the Head of the European Parliament delegation for relations with the Maghreb countries, Mr. Pier Antonio Panzeri. Both sides "have reviewed the relations between Algeria and the European Union (EU) and uniting the two parliaments, Algerian and European," said a statement from the NPC. On this occasion. Mr. Ould Khelifa said that relations with the EU 'first partner of Algeria are secure,"

Azerbaijan: The 10th session of the Azerbaijan-Russia commission for interparliamentary cooperation was held in Baku.

The Deputy Speaker of the Milli Majlis (Parliament) of Azerbaijan Valeh Aleskerov and Deputy Chairman of the Federation Council Svetlana Orlova are the co-chairs of the commission.

The meeting is being attended by members of parliament and ambassadors of both countries.

The meeting will consider the appointment of deputy chairs and changes in commission staff, expansion prospects of humanitarian, economic, trade and legislative cooperation. The final protocol will be signed and the place and date of the next committee meeting will be agreed at the meeting.

Saudi Arabia: The Consultative Council approved with a majority the draft agreement between the Kingdom of Saudi Arabia and the State of Kuwait in the field of air transport services. The approval followed hearing the report of the Transportation, Communications, and Information Technology Committee. The Committee recommended to approve the draft agreement because it dealt with all aspects relevant to the air transport industry in terms of charges and tariffs for using airports, air safety and airport security, etc.

The Council also approved with a majority the draft framework agreement of cooperation in the field of agriculture, animal resources and fisheries between the Kingdom and the government of the Republic of the Sudan. The Committee on Housing, Water and General Services stressed that the agreement will enhance cooperation between the two countries in the areas of agriculture, animal and fish resources, and promotes investment. **Pakistan:** Newly elected members of Pakistan's National Assembly were sworn in on Saturday First of June 2013 , officially celebrating the first transition of power between democratically elected civilian governments in the 66-year history of the country.

The PML-N won 176 seats in the 342-member lower house of Parliament and is expected to rule in an alliance with some independent legislators. The previous ruling Pakistan People's Party earned 39 seats.and the Tehreek-e-Insaf party has won 35 seats.

**Palestine:** The Palestine National Council emphasized in a statement issued 14/5/2013 on the 65th on anniversary of the Nakba that the Palestinian national rights of return in accordance with resolution 194 and selfdetermination are inalienable.

The statement said that the suffering of the Palestinian people in the homeland and in the diaspora by displacement from their land since 65 years is not only the responsibility of Zionist death squads and criminals, but also the international community, which neglected the issue, demanding it to be fair to the Palestinian people and their legitimate rights according to the international legitimacy resolutions, particularly resolution 194 and establishment of their independent state with Al-Quds as its capital.

The Palestinian National Council called on this occasion to end the division and achieve the national unity – led by PLO, the sole and legitimate representative of the Palestinian people, for confronting the aggression and the occupation and the terrorist practices against our people and their sanctities.

### **Secretary General**

### At the 19th Regular Conference of the APU: Secretary General Confirms Parliaments Role in Reducing tension



H.E. the PUIC Secretary General, accompanied by H.E. the Assistant secretary General, attended the 19th Regular Conference of the Arab Parliamentary Union (ARAB IPU), held in the State of Kuwait, on 9-10 April 2013, under the high auspices of H.H. Sheikh Sabah Al-Ahmed Al-Jaber Al- Sabah, the Emir of Kuwait. The Secretary General delivered a speech at the conference in which he called for enhancing understanding among sects communities and states aimed at developing mutual respect and equality, especially between Islamic parliaments and their counterparts in the West in order to eliminate ideas of hatred.

In his speech the Secretary General stressed that the PUIC calls for tolerance and compassion, and rejects violence as well as all forms of aggression, particulary, murder, irrespective of colour, religion and race. PUIC condemnation of terrorism

emanates from the fact that the latter runs counter to the precepts of Islam. He underlined that the PUIC distinguishes between terrorism, in all its manifestations, and peoples' right to resist occupation and colonization for the liberation of their homelands and the restoration of their legitimate rights which are guaranteed by international conventions.

His Excellency met on the sidelines with a number of their Excellencies the Parliament Speakers and heads of participating delegations.

### Secretary General Participates in UNAoC Forum

H.E. PUIC Secretary General Prof. Mahmud Erol KILIC participates in the 5th United Nation Alliance of Civilization (UNAoC) Forum in Vienna, on 26-27 February 2013.

This Forum is organized in the context of the 6th edition of the Global Junior Challenge which aims at reflecting on the 21st Century challenges for innovation in education, integration, sustainable development and the eradication of world poverty.

The competition in the challenge is open to schools, associations, public and private institutions, cooperatives, universities, companies and individuals of any age and any country.

### **PUIC Secretary General Participates in Islamic Summit**

His Excellency the PUIC Secretary General, Prof. Dr. Mahmud Erol KILIC, accompanied by Assistant Secretary General, participated as an observer in the proceedings of the 12th Islamic Summit Conference which was held in Cairo, Arab Republic of Egypt, on 6 – 7 February 2013, corresponding to 25 – 26 Rabiul Thani 1434 H. Participants in the Summit discussed a number of significant subjects included in the Conference agenda which were of concern to the Ummah and would enhance joint Islamic action.

Prof. KILIC met on the sidelines of the conference with some members of delegations and their discussions focused on promoting cooperation between the PUIC and the OIC in order to serve common objectives.



### On the Sidelines of the IPU Meetings: PUIC Holds Consultation Meeting

The Consultative Meeting of the PUIC was held on the sidelines of the 128th IPU Assembly on Saturday 23rd March 2013 in Quito, Capital of the Republic of Ecuador.

At the beginning the meeting was chaired by H.E. Mr. Fahd Al Rashid, Speaker of the National Assembly of Kuwait, and then proceeded under the chairmanship of H.E. Mr. Karim Ghallab, Speaker of the House of Representatives of Morocco.

More than a hundred PUIC members participated in the meeting.

At the outset, H.E. Prof. Mahmud Erol KILIÇ, PUIC Secretary General delivered a brief speech concerning the meeting, then the participants proceeded to discuss the agenda which included: 1. Proposal presented by the UAE Federal National Council on "Role of Parliamentarians in reaching an international agreement criminalizing insulting religious symbols and sanctities, and emphasizing mutual respect between world religions and civilizations as a major requirement for international peace and security".

The attendees supported the proposal.

2. Consideration of proposals submitted by the parliaments of : Hashemite Kingdom of Jordan; Kingdom of Morocco; and Syrian Arab Republic, concerning the Emergency Item.

Following exhaustive discussion, it was decided that member delegations may support any of these proposals deemed appropriate.

The 128th IPU Assembly approved the proposal of the JORDANIAN Parliament as an Emergency Item which stipulates as follows: "Role of Parliaments in urging their respective governments to shoulder their international and humanitarian responsibilities towards Syrian refugees and to support the States which receive them".
